Dear Tougaloo College Community,

Dr. Carmen J. Walters, Tougaloo College's 14th president, has informed the Board of Trustees of her intent to step down, effective June 30, 2023, at the completion of the 2022-2023 fiscal year.

On behalf of the Board of Trustees, we thank Dr. Walters for her service to the College and her efforts to build upon our 155-year history. We are especially grateful to Dr. Walters for her leadership over these past four years - leading the College through the COVID-19 global pandemic, significantly increasing the College's endowment, and strengthening our external partnerships with organizations such as the United Negro College Fund (UNCF), among others. We, along with the entire Tougaloo College family, wish her well in her future endeavors.

As we look forward, the Board of Trustees will conduct a national search for Tougaloo College's next president. The Board will establish a search committee, to be co-chaired by Trustees Dr. Blondean Y. Davis and Dr. Chris Gilmer, both of whom are well-respected administrators in academia. The search committee will be composed of faculty, staff, students, alumni, and community members. To lead the College in an interim capacity, the Board has unanimously appointed Dr. Donzell Lee to serve as President, effective July 1, 2023.

Dr. Lee is a highly respected university administrator, faculty leader, public servant, and educational consultant with more than 40 years of diverse leadership experience. He has served as Interim President of Alcorn State University during its 2018-19 presidential search and later as Special Assistant to the President during the 2019-2020 academic year. Prior to that service, he served Alcorn for decades in numerous roles, including Provost and Executive Vice President for Academic Affairs, Vice Provost, Dean of the School of Graduate Studies, Chair of the Department of Fine Arts, and tenured Professor, among others. An expert in reaffirmation of accreditation, Dr. Lee also led Alcorn's successful reaffirmation efforts with the Southern Association of Colleges and Schools (SACS). Upon his retirement in July 2020, he was named Professor Emeritus at Alcorn. Dr. Lee holds a Ph.D. in music education from Louisiana State University, master's degree from Stanford University, and bachelor's degree from Xavier University of Louisiana.

We greatly appreciate Dr. Lee for his willingness to pause his retirement and lend his extraordinary leadership talents and deep expertise in higher education to our beloved Eagle Queen, and we welcome him to the Tougaloo family.

#### A Message from the President



Dear Tougaloo College Family,

Tougaloo College is a remarkable institution with enviable academic excellence and activism legacy. Its impact on our alumni, the state of Mississippi, and our nation is immeasurable, and I consider myself fortunate to have had the opportunity to lead this historic institution. As such, it is bittersweet to an-

nounce that I will step down as president of Tougaloo College, effective June 30, 2023.

I am overjoyed by all that my administrative team and I have accomplished since my arrival in July 2019. While navigating through a devastating pandemic and combating record-breaking low enrollment for HBCUs nationwide, Tougaloo College made significant strides. I celebrate this progress with our entire Tougaloo family, including our students, faculty, staff, Board of Trustees, and alumni. Together, we have:

#### Academics

- Navigated through a devastating COVID-19 pandemic, requiring us to pivot to remote teaching and learning, adjust finances to ensure continuity in cash flow, and implement COVID prevention practices to manage all teaching, learning, work, and other activities safely and orderly.
- Successfully weathered a cyber-attack that attempted to disrupt and access data, functions, or other restricted areas of the College's network system.
- Improved our national ranking. In 2021, US News & World Report ranked Tougaloo No. 2 among the top three National Liberal Arts Colleges; advanced Tougaloo from No. 16 to No. 12 as one of the country's top best Historically Black Colleges and Universities; and named Tougaloo No. 3 as a social mobility performer among National Liberal Arts Colleges.
- Created opportunities for more high schoolers to access college courses. The Board of Trustees approved the Dual Enrollment/Dual Credit policy created to increase the number of high school students who simultaneously earn college credit while in high school, paving the way for more than 50 high school students to obtain their associate degrees while earning their high school diploma at Tougaloo College.
- Developed new academic programs in Cyberse-

curity, Data Science, and Business Accounting) to grow enrollment, maintain relevancy in the curriculum, and differentiate the institution.

#### Athletics

- Celebrated winning teams. The Men's Basketball team celebrated winning two back-to-back Gulf Coast Athletic Conference Championships, and the College recognized their achievement with ring ceremonies.
- Launched the Electronic Sports (Esports) video competition program, winning Fall 2022 and Spring 2023 championships.
- Added women's flag football, men's and women's soccer, and competitive cheer and dance to the athletic program.

#### **Facilities**

- Improved our facilities. The College invested over \$4 million to renovate/upgrade campus facilities, including Galloway Hall, New Women's, Renner, and AA Branch Residence Halls, Jamerson Hall, Zenobia Coleman Library, Pope Cottage, George A. and Ruth B. Owens Health and Wellness Center, and Woodworth Chapel. In addition, renovations are underway to upgrade Warren Hall Cafeteria and install additional windows in Woodworth Chapel.
- Consulted with a landscape architect to develop a plan that enhanced the College's outdoor spaces, including trees, plantings, walks, and landscapes.
- Added exterior banners and signage for major campus facilities.

#### National Recognition

- Strengthened our financial standing. In 2021, Tougaloo made the Top 10 Forbes List of Achievers and Most Improved Colleges Financially.
- Been featured by Philanthropic People, which highlighted Tougaloo in its February 28, 2022 issue for the gift of \$10 million from Reed Hastings, CEO of Netflix, and his wife, film producer Patricia Quillin.
- Been highlighted by the Chronicle of Philanthropy, which featured Tougaloo College in its June 1, 2021 issue for the \$6 million gift from Philanthropist MacKenzie Scott.

#### **Fundraising**

 Attracted national philanthropists MacKenize Scott, Reed Hastings, Patty Quillens, and others including several anonymous donors, one who donated\$2.5 million) to the College whose investments afforded the institution to grow the endowment by more than 50 percent from \$14 million in 2019 to \$31 million in 2023.

- Established an endowed scholarship for male students. I gifted \$50,000 to the College to honor my husband's legacy, Mr. Wayne Walters, establishing an endowed scholarship to support black and brown males majoring in STEM.
- Launched the inaugural Tougaloo College President's Circle honoring donors who have given one million dollars or more to Tougaloo College in their lifetime.

#### Institutional

- Launched the 2021-2026 strategic plan, Preserving the Past, Advancing Tomorrow.
- Celebrated the College's sesquicentennial with events and activities commemorating lifelong traditions, honoring liberal arts education, recognizing inspiring visionaries and fearless leaders who made the institution's progress possible, acknowledged donors, named several interior, and external spaces on Tougaloo's campus.
- Nurtured our social justice mission by collaborating with the Episcopal Church on a proposal to build the Tougaloo College Center for Racial Justice and Equity. This world-class center would combine groundbreaking academic research and meaningful scholarship in ways that allow Tougaloo to make substantial contributions to creating a more just and equitable society. The Center would provide a home for the college's Civil Rights documents and the Tougaloo College Archives. Most importantly, this center would enable the college to attract new students and scholars, develop new parts of our campus footprint, and advance our legacy of advocating for social change. The Board is exploring this option further.
- Made history again, becoming one of nine HBCUs in the Howard University-led UARC consortium focusing on tactical autonomy, artificial intelligence, cybersecurity, machine learning, and K-12 activities to attract students to STEM field careers. Tougaloo is the only four-year liberal arts institution associated with a UARC, collaborating with Virginia State University, Hampton University, Delaware State University, Bowie State University, Tuskegee University, Florida Memorial University, Norfolk State University, and Jackson State University in research endeavors in collaboration with the United States Department of Defense.

#### Marketing/Branding

 Unveiled the Board-approved new trademarked logo, seal, and other marks designed to reflect the College's forward momentum, solidify the institution's name recognition among the nation's best colleges and universities, and build pride and visibility.  Partnered with the Collegiate Licensing Company and Logo Brands Design Approval and Royalties to protect, promote, grow, and maximize our potential to sell our brands.

#### Partnerships

- Digitized 100 percent of the College's American art collection through the support of the Henry Luce Foundation.
- Partnered with the United Negro College Fund and the Educational Advisory Board (EAB) through the Transformation Grant to strengthen our capacity to grow the College's enrollment. As a result, this Spring 2023, we successfully disrupted the application lag, enabling the institution to increase the number of freshman students applying to Tougaloo by 11.74 percent and increase transfer applications by 69.47 percent for Fall 2023. This Fall 2023 Freshman class includes 7 of the 15 Valedictorians and Salutatorians of the Jackson Public School District Class of 2023.
- Partnered with Hyatt-Fennell Executive Search Firm to recruit qualified leaders to fill three executive-level positions.
- Partnered with national industry technology leader Ellucian to strengthen the technological infrastructure. As a result, our technology is more robust across the board, and this partnership is a huge step forward as we make inroads to launch Tougaloo Online, prepare the College for a stronger future, and evolve to provide the best technology to the campus community.

As I reflect upon my time as President, I wish to thank the Board of Trustees, faculty, staff, students, and alumni for their support. It has been the honor and privilege of a lifetime to represent this distinguished institution through my interactions with several national leaders, policymakers, and other stakeholders. I will forever be grateful for the opportunity to represent Tougaloo College.

Our beloved Eagle Queen is magnificent to behold. Tougaloo has a rich history and a promising future. I will always reflect on my tenure at the College with pride and root for its continued success as a passionate supporter.


What a journey it has been!

# TCNAA Constitution and By-laws: New Amendments Approved

During the annual Tougaloo College National Alumni Association's general membership meeting, held on Saturday, May 6<sup>th</sup>, the membership voted on and passed the following amendment changes to the TCNAA By-laws and TCNAA Local Chapter Guide.

#### **Amendments to the TCNAA Bylaws**

Article XV, Section 6 (Qualifications):

Add "for one year" to "C": Must be an active member of a local chapter when such a chapter exists in his/her area."

Now reads: Must be an active member of a local chapter when such a chapter exists in his/her area for one year.

Add "for two years" to "D": Must be a financial member of the Association."

Now reads: Must be a financial member of the Association for two years.

#### Amendments to the Local Chapter Guide

*Article XIII, Section B (Nomination & Elections)* 

Replace "due paid by March 30" with "dues paid by January 31."

Now read: The Nominations and Elections Committee will meet on a predetermined date (to be set by the chairperson) for the purpose of collecting, opening, and reviewing all nominations. All nominees meeting the criteria will be placed on the election ballot. Ballots will be mailed to all active TCNAA members (dues paid by January 31)

*Article XIII, Section C (Nomination & Elections)* 

#### Revise to allow for electronic balloting/voting


The By-laws Committee will work to add the use of electronic voting to the TCNAA Local Chapter Guide.



We are delighted to share the exciting news of our recently awarded scholarships for the 2022-2023 academic year. These scholarships recognize students who have demonstrated outstanding academic achievements and a commitment to community service. Rokiyah Hobbs is the recipient of the First-Year Student Scholarship and Kelan Pickett was awarded the Returning Student Book Scholarship.

Hobbs is a 2022 graduate of Greenville High School, and is the daughter of Courtney Franklin-Hobbs. While at Greenville she served as SGA president, cheerleader, and member of the Beta Club. Pickett, a native of Gautier, is a rising senior English major and served as the 2022-2023

other Minority Serving Institutions (MSIs). The Research Foundation fulfills that mission by helping HBCUs and MSIs secure and execute federal and private sector grants and contracts and by facilitating partnerships with Federal agencies and the private sector.

Most of Rosenthall's career has been dedicated to working with or for HBCUs or a consortium of HBCUs. He has served as Director of the Urban Environment Institute at Howard University; Vice President for Research, Economic Development, and Public Service and Executive Director of the 1890 Program at South Carolina State University; and Vice President for Research, Advancement and Economic Development at Grambling State University.

Rosenthall has also served as Director of Environmental Justice for the National Association for the Advancement of Colored People (NAACP) and the Washington representative for the National Conference of Black Mayors. In 2007, he formed EJ Conference, Inc., a non-profit organization that produced the Annual State of Environmental Justice in America Conference. This continued for six consecutive years when he assumed full-time duties at South Carolina State University.

Rosenthall graduated from Tougaloo College with a bachelor's degree in mathematics and from George Washington University with a Juris Doctorate Degree. He is an ordained deacon at Alfred Street Baptist Church in Alexandria, Virginia. Formal recognition of Rosenthall will take place in October at the Hall of Fame Banquet during Founders' Weekend.

SGA Vice President. Presented inaugurally in Fall 2022 to students enrolled at Tougaloo, the First Year Student Scholarship awards \$2,000 the first year and can be renewed for up to three years. The Returning Student Scholarship provides a \$500 book scholarship to a currently enrolled student.

By providing financial assistance and recognition, we hope to support the next generation of Tougalooians in their pursuit of academic and personal growth.

#### 2023 Retool Your School Campaign

The 2023 Retool Your School Campaign was held on February 27, 2023 through March 26, 2023. Voting was conducted to help Tougaloo College receive funds to provide renovation supplies from Home Depot to enhance the campus. Campus projects submitted to Home Depot for this year's competition were Holmes Hall (*two offices and the art suite*), James Coleman Athletic Complex Upgrades, and Galloway Hall (*2nd floor restrooms and the basement student lounge area*). In partnership with Jackson State University (in Cluster One), Tougaloo College won the second-place prize of \$100,000 in renovation supplies. Previously, Tougaloo finished 1<sup>st</sup> in 2021 and 2022 in its Cluster (3) and won Campaign of the Year honors in 2021.

Tougaloo College is deeply grateful for the dedication shown by alumni, family members, and friends throughout the duration of this year's campaign!

#### **About the Retool Your School Initiative**

During the 2023 Campus Improvement Grant voting challenge, HBCU students, alumni and others voted for their favorite HBCUs. This year, HBCU supporters cast over 13 million votes – a 30% increase over 2022.

The schools were split into three clusters based on student enrollment.

- Cluster 1 schools enroll more than 4,000 students.
- Cluster 2 schools enroll between 3,999 and 1,201 students.
- Cluster 3 schools enroll fewer than 1,200 students.

This year, The Home Depot increased Campus Improvement Grant awards at all levels by at least two times the 2022 amount. For example, 2022's first-place winners each received \$75,000. Each 2023 first-place winner was awarded a grant of \$150,000.



Tougaloo College accepts three types of contributions: cash, noncash, and in-kind

Cash contributions include payments made by cash, check, electronic funds transfer, online payment service, debit card, credit card, payroll deduction, or transfer of a gift card redeemable for cash;

Noncash contributions are property with no restriction placed on them. This includes publicly traded stock, clothing, wine collections, art, jewelry, antiques, collectible, automobiles, boats, recreational vehicles, and even your home. The amount of your deduction is generally the donated property's "fair market value". The job of determining worth is the responsibility of the donor;

In-kind contributions are gifts of tangible goods or services that alleviate costs to Tougaloo College. Examples of inkind gifts include:

- Goods like computers, software, furniture, and office equipment.
- Services such as meeting space, photocopy and mail services, and administrative/financial support.
- Expertise like legal, tax, or business advice, marketing and website development, and strategic planning.

What is or is not an in-kind gift to the College can be a point of confusion.

In-kind contributions are gifts of tangible goods or services that alleviate costs to Tougaloo College and can be used to advance Tougaloo's mission.

Examples of in-kind gifts include:

- Goods like computers, software, furniture, and office equipment;
- Services such as meeting space, photocopy and mail services, an administrative/financial support;
- Expertise like legal, tax, or business advice, marketing and website development, and strategic planning.

Please note that such contributed services cannot be counted as a gift and do not qualify as a charitable tax deduction to the donor. However, a donor of services may be able to deduct expenses incurred while performing said services. In such cases, please consult with a trusted tax advisor.

#### Contributions that may be mistaken for in-kind include:

- Tuition and/or related educational costs for an identified needy or worthy student;
- Direct scholarships to identified students; Travel expenses to and from official Tougaloo College events; Value of your time and/or services;
- Personal expenses incurred while volunteering.

According to IRS Publication 526, contributions earmarked for a particular student are not charitable contributions, and therefore not tax deductible. "You can't deduct contributions to specific individuals, including contributions to individuals who are needy or worthy. You can't deduct these contributions even if you make them to a qualified organization for the benefit of a specific person. But you can deduct a contribution to a qualified organization that helps needy or worthy individuals if you don't indicate that your contribution is for a specific person." The calendar fiscal year ends at 11:59 pm on Sunday, De**cember 31.** In order for your gift to be considered a 2023 tax year gift, it must be made, received, and/or postmarked by Sunday, December 31.

**Hand delivered gifts**: For gifts that are hand delivered to Tougaloo College, the delivery date is the date we actually receive the gift. Hand delivered gifts must be received by December 18, 2023. Tougaloo College will close about December 18, 2023 for the Winter Break.

Credit Card Gifts: You are encouraged to make credit card gifts to Tougaloo at www.tougaloo.edu/ as these gifts can be made even when the College is closed.

Gifts Sent by Check: The IRS considers a charitable gift made by check complete at the time the check is delivered or mailed, and the postmark is the evidence of the gift

#### **TCNAA Overview**

What does TCNAA mean (acronym)? TCNAA means Tougaloo College National Alumni Association and is often referred to as the "Association."

What is the purpose and role of TCNAA? The purpose of TCNAA is to promote the mission, interests, purposes, and ideals of Tougaloo College, including recruitment and fundraising initiatives.

Who is the official spokesperson for TCNAA? The President of TCNAA is the official spokesperson of the Association.

Does TCNAA operate independently from the College? Yes, TCNAA is a separate 501 3(c) entity and operates independently from the College.

Does TCNAA provide input regarding the College's day-to-day operations/decisions/oversight? No, TCNAA does not provide any input to the day-to-day operations of the College.

What is the primary corporate/organizational structure of the TCNAA? TCNAA Board of Directors (which includes the Association's officers, Alumni Representatives to the College's Board of Trustees, Alumni Regional Representatives, and Chapter Presidents) and active alumni (those who have paid national dues).

How does the Association communicate and promote its mission statements? The Association communicates and promotes its mission statement through the TCNAA website, activities, social media platforms, and other initiatives.

What is the role of the TCNAA Alumni Representatives to the Tougaloo College Board of Trustees? The Alumni Representatives to the Tougaloo College Board of Trustees advocate for alumni interests while embracing their responsibilities and fiduciary duties as a College Trustee.

How does TCNAA support the College's fundraising efforts? The Association jointly supports the College's various fundraising efforts through gifts, scholarships, volunteerism including social media communication and promotions.

What activities/events does TCNAA support that benefits the College? TCNAA supports activities such as Pre-Alumni Council programs, UNCF National Alumni Council, Concert Choir tours, Commencement Activities, Annual Alumni Gathering and Banquet, and Alumni Hall of Fame Induction.

Does TCNAA have authority over alumni chapters management and/or activities? Alumni Chapters fall under the direction of TCNAA pursuant to the Association's Chapter Guide. However, the Association does not manage or di-

rect alumni chapter activities and events.

What is the purpose and role of the Division of Institutional Advancement also known as the Office of Institutional Advancement? The Division of Institutional Advancement facilitates the understanding, participation, and support of Tougaloo College's students, faculty, alumni, trustees, parents, friends, corporations, foundations, legislators, and others who have an interest in promoting and supporting the College.

What is the purpose and role of the Office of Alumni Relations? The Office of Alumni Relations serves as the intermediary between the College and the alumni through the Division of Institutional Advancement and work closely with TCNAA to maintain the integrity of the Tougaloo College legacy.

#### **Membership**

Are all Tougaloo College alumni automatically members of TCNAA? No, Tougaloo alumni are not automatic members of TCNAA. Alumni may become members of TCNAA by paying the Association membership dues.

How can I become a member of TCNAA? To become a member, please visit the TCNAA.org website and click the membership tab.

Can I join TCNAA, if I am not a member of an alumni chapter? Yes, you can join TCNAA if you are not a member of an alumni chapter. However, chapter participation is encouraged.
